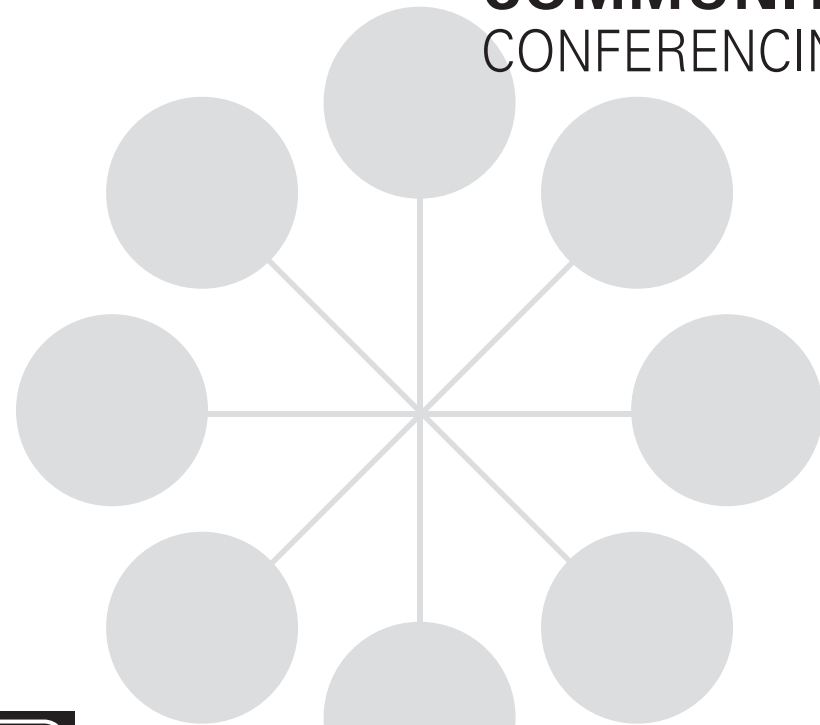
**Steps for the YACC Volunteer**

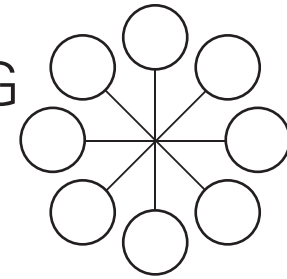

# YOUNG ADULT **COMMUNITY** CONFERENCING



**YACC** is a unique, comprehensive Community Service program designed as a sentencing alternative for 18–24 year olds charged with summary-level “quality of life” offenses such as noise violations, disorderly conduct, public drunkenness, and underage drinking.

**YACC** is a structured forum in which the young adult offender and trained representatives of the victimized community meet together to determine a meaningful, appropriate consequence that benefits the community.

**YACC** is a circle process rooted in restorative justice practices. It seeks to address victim needs, offender competencies, and community responsibility in repairing the harm done by crime.

***Restorative justice involves victims and community in the criminal justice system. Offenders achieve accountability through taking responsibility and making amends.***



**Community Representatives** invited to participate in the YACC program are trained volunteers who have been negatively impacted by the types of behavior for which the offender has been cited.

**Victim(s)**, if any are identified, will be invited to participate.

**Young adult offenders** may be given an opportunity to participate in exchange for some portion of their fines and costs...

- if they are 18–24 years old, and
- if they are cited for a non-traffic crime, and
- if they have pled or been found guilty of that crime

**Support persons** for the offender and for the victim, whether invited by them or appointed on their behalf, will also be included to establish a safe environment for all participants.

**A facilitator**, trained in community conferencing, will lead the group process.



- You, as a volunteer, will have the opportunity to express problems and frustrations you experience as a result of “quality-of-life” crime.
- You will have a say in the development of meaningful consequences for young adult offenders who have caused harm to your community.
- You will have a voice in the criminal justice process relative to minor crimes which affect your community.
- You will assist young adults in learning to conduct themselves appropriately in their community.
- You will be part of giving and receiving benefit from a negative situation.
- You will be part of strengthening ties in your community.

**Note:** Offender participation in the YACC program is not a right. This alternative sentencing option is offered to defendants at the discretion of the court. If the terms of the contract created at a YACC session are not fulfilled, or if the offender does not cooperate with the program, fines and costs sentenced by the court remain due.
